### ORGANIZATION AND GRANT BACKGROUND

The mission of Sierra Health Foundation is to invest in and serve as a catalyst for ideas, partnerships and programs that improve health and quality of life through convening, educating and strategic grantmaking.

Sierra Health Foundation forges new paths to promote health, racial equity and racial justice in partnership with communities, organizations and leaders in 26 counties in Northern California.

Sierra Health Foundation’s funding region includes the following counties: Alpine, Amador, Butte, Calaveras, Colusa, El Dorado, Glenn, Lassen, Modoc, Mono, Nevada, Placer, Plumas, Sacramento, San Joaquin, Shasta, Sierra, Siskiyou, Solano (eastern), Stanislaus, Sutter, Tehama, Trinity, Tuolumne, Yolo and Yuba.

Since 2008, our organization has awarded approximately \$8.3 million through the Responsive Grants Program in support of community-driven efforts to **improve health, promote access and reduce health inequity** throughout our 26-county funding region.

### FUNDING OPPORTUNITY AND BACKGROUND

Responsive grants are available to qualifying nonprofit organizations and public agencies that serve people living in Sierra Health Foundation’s 26-county funding region (see map on page 4). Sierra Health Foundation has committed a total of \$400,000 to this program in 2024, with grants of up to \$10,000 available to support projects and activities that advance health and racial equity and improve health and quality of life. This opportunity will prioritize strategies affected by the California budget deficit, that impact health and quality of life for Californians.

#### **Social Determinants of Health and Health and Racial Equity**

Sierra Health Foundation has a broad definition of health, believing there is much more to health than healthcare. Health is influenced by many factors, including socioeconomic conditions, environment, education, income, housing, neighborhood safety and other drivers of health outcomes—factors that have come to be known as the Social Determinants of Health. Where we live, work and play have a considerable influence on our health.

Health equity means achieving the highest possible standard of health for all people and giving special attention to the needs of those at greatest risk of poor health, based on social conditions.<sup>1</sup> Racial equity “is the condition that would be achieved if one’s racial identity no longer predicted, in a statistical sense, how one fares. When we use the term, we are thinking about racial equity as one part of racial justice, and thus we also include work to address root causes of inequities, not just their manifestation. This includes elimination of policies, practices,

attitudes, and cultural messages that reinforce differential outcomes by race or fail to eliminate them.”<sup>2</sup>

Through the Responsive Grants Program, Sierra Health Foundation will invest in communities and organizations that promote health and racial equity to address health disparities and the social determinants of health.

### **Addressing the California State Budget Funding Gaps**

Sierra Health Foundation supports community-based organizations and public agencies that may be impacted by these budget cuts and will prioritize related projects in the selection process. Based on the May revise of the California State Budget, there are potential and possible budget cuts not limited to the following areas:

- Health
- Homelessness and Housing
- Economic Security
- Education
- Justice System
- Workforce and Climate Change

### **Funding for Rural Communities of Northern California**

At least 30 percent of Responsive Grants Program funds will be available to support projects that benefit rural areas of Sierra Health Foundation’s funding region. The remaining funds will be available for activities benefiting urban areas and urban/rural areas.

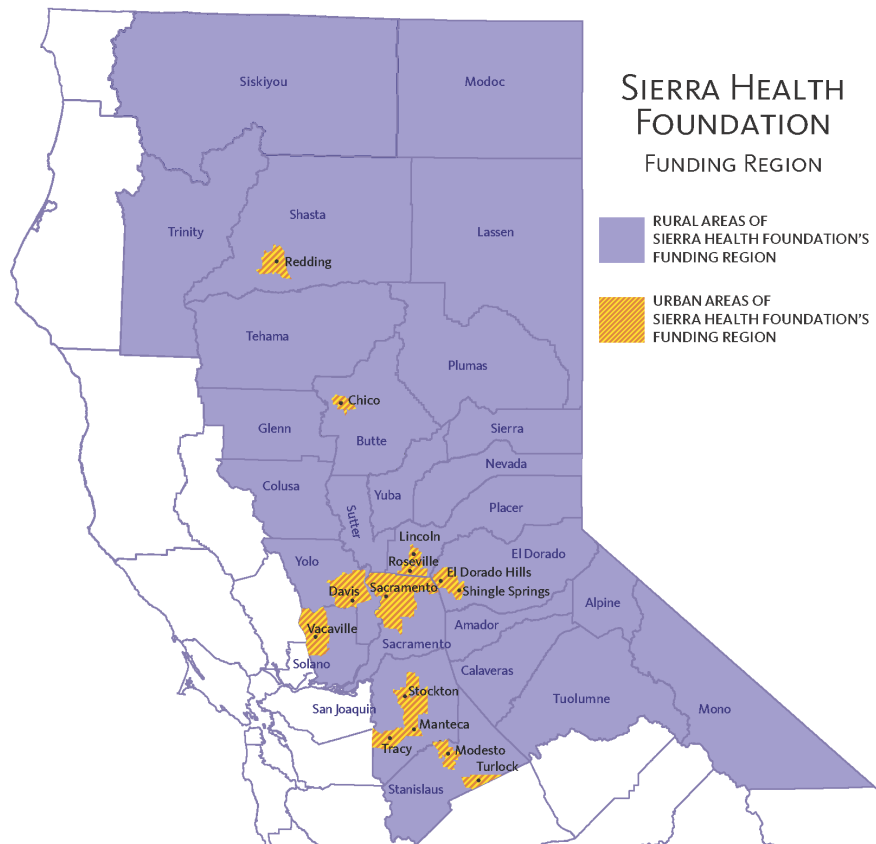
### **What is Rural?**

For purposes of this grant program, Sierra Health Foundation defines rural, including frontier, as a Medical Service Study Area (MSSA) that has a population density of 250 persons or less per square mile and has no incorporated area greater than 50,000 people.<sup>3</sup> To determine if the geographic area to be served by your proposed project is rural, see the map below, which shows the urban and rural MSSAs in Sierra Health Foundation’s funding region. As a rule, MSSAs are deemed to be “rational service areas” for purposes of designating health professional shortage areas, medically underserved areas, or medically underserved populations. An MSSA is composed of one or more complete census tracts. Sierra Health Foundation combines rural and frontier communities into its rural category for the purposes of this grant program. **Eligibility Criteria**

Sierra Health Foundation will fund nonprofit organizations that are tax-exempt under Section 501(c)(3) of the Internal Revenue Code and are designated a 509(a)(1) or 509 (a)(2) organization or tribal or urban Indian entities. Proposed projects or activities must benefit people living in one or more of the 26 counties of Sierra Health Foundation’s funding region (see map above).

Sierra Health Foundation will also fund public agencies. Fiscal sponsors for entities that are not qualifying 501(c)(3) nonprofit organizations are eligible to apply. Fiscal sponsors may apply on behalf of more than one organization or collaborative group.

For applicants that are not fiscal sponsors, only one grant proposal per eligible 501(c)(3) organization or public agency will be considered. This limitation applies to multiple departments of a government agency or university, and multiple chapters of an organization using the same tax-exempt ID number. If we receive more than one application per eligible applicant organization, we will only consider the first application received. Fiscal sponsors are exempt from this limitation.

## **FUNDING INFORMATION**

Grants will cover activities for the period September 1, 2024, through August 31, 2025.

The maximum grant amount is \$10,000. Applicants may request less than \$10,000.

Grants for capital equipment will be considered.

Up to 15% of direct costs may be requested for indirect costs.

## **FUNDING RESTRICTIONS**

The following will not be funded:

- Debt retirement
- Operational deficits
- Partisan activities
- Individuals
- Religious organizations for explicit religious activities
- Activities that exclusively benefit the members of sectarian or religious organizations
- 509 (a)(3) supporting organizations
- 501 (c)(4) organizations or lobbying activities

## **FUNDING EXAMPLES**

These are just some examples of types of projects that would be considered for funding. What applicants propose is not limited to these examples:

- Increasing access to and quality of health services by supporting infrastructure of clinics that serve medically underserved populations.
- Increasing bilingual community health workers in underserved neighborhoods where English is a second language through internship and leadership development classes.
- Providing infrastructure support for crisis lines.
- Increasing access to shelter in rural communities through shelter operational support.
- Addressing homelessness by supporting street outreach.
- Increasing food access through organizational support to food pantries.
- Reducing domestic violence through prevention and outreach activities.
- Increasing assistance for people with disabilities through housing support programs.
- Increasing access to higher education through programs designed to provide support for low-income students and students of color, such as housing, food and transportation programs.
- Creating and/or supporting coalitions to address racial and gender equity by advocating for justice reform.
- Promoting clean air and preventing pollution through education or enforcement of relevant air quality policies.
- Supporting community groups or coalitions advocating for increased and equitable walking/biking safety and access.

- Youth Engagement, Organizing and Advocacy
- Peer Learning
- Direct Service

## **SELECTION AND EVALUATION CRITERIA**

Applicant selection will be based on a complete and responsive application demonstrating a mix of experience, capacity, and potential impact on the community. Applications will be reviewed on how well the proposed activities match the funding opportunity's intent, anticipated overall impact, and the strength of the project team and proposal.

The most competitive applications will:

- Respond to gaps in the California State budget.
- Promote health and racial equity and address health disparities.
- Support projects that improve health and quality of life.
- Demonstrate approaches to solving issues that impact health, such as education, employment, housing, environment, neighborhood safety and other drivers of health outcomes.
- Clearly explain why the applicant organization and, where appropriate, partner agencies are best suited to be successful with the proposed project.
- Clearly describe the target population, utilizing data.
- Make a data-driven case for the need related to the target population.
- Leverage resources and/or demonstrate sustainability, if applicable.
- Include a reasonable project scope and budget, based on Responsive Grants Program parameters.
- Describe the anticipated difference the project would make.

Additionally, the geographic and demographic diversity of the region and variety of issue areas will be considered in the selection process. Priority will be given to organizations that demonstrate fiscal impact from California state budget cuts.

## **PROJECT TIMELINE**

Grants will cover activities for the following time period: September 1, 2024, through August 31, 2025.

## **REPORTING REQUIREMENTS**

Awardees will be required to submit narrative and financial reports 30 days following the end of the funding period, reporting on activities and outcomes included in the proposal. Report forms may vary and potentially include videos or photos, utilizing other materials, or verbal reporting.

## **APPLICATION TIMELINE**

At Sierra Health Foundation's discretion, the application timeline below is subject to change to best meet programmatic needs and funding requirements.

To be considered, your proposal must be submitted by 1 p.m. (Pacific Time) on the deadline date. Proposals received after the due date/time will not be reviewed. Submission before the deadline date is advised in case you experience technical difficulties with submitting your application through the portal. We may not be able to respond to your requests for help on the deadline date.
