
Background



About the Responsive Grants Program (RGP)

- The Responsive Grants Program is a program of Sierra Health Foundation
- Began in 2008 and ran through 2019
- Funds are dedicated to serving organizations within Sierra Health Foundation's 26-county funding region





Program Goal

To support innovative programs and projects that improve health and quality of life for people living in Sierra Health Foundation's 26-county funding region.











Program Scope

- \$400,000 will be granted to nonprofit organizations and public agencies within Sierra Health Foundation's 26-county funding region
- Individual grants of \$10,000 or less will be awarded
- At least 30% of funds are reserved for rural communities; the remaining 70% will be available for both urban and rural activities

What We Will Fund

Projects or activities designed to address health disparities and promote health equity to improve health and quality of life.

In 2024, this program will prioritize strategies affected by the California budget deficit, that impact health and quality of life for Californians.











Eligibility

- Sierra Health Foundation will fund nonprofit organizations that are tax-exempt under Section 501(c)(3) of the Internal Revenue Code and are designated a 509(a)(1) or 509 (a)(2) organization or Tribal or urban Indian entities.
- Public agencies and fiscal sponsors for entities that are not qualifying 501(c)(3) nonprofit organizations are eligible to apply.
 Fiscal sponsors may apply on behalf of more than one organization or collaborative group.
- Proposed projects or activities must benefit people living in one or more of the 26 counties of Sierra Health Foundation's funding region (see map on slide 6 or in Request for Applications).



Types of Projects

Examples of eligible projects

- Increasing access to and quality of health services by supporting infrastructure of clinics that serve medically underserved populations.
- Increasing bilingual community health workers in underserved neighborhoods where English is a second language through internship and leadership development classes.
- Providing infrastructure support for crisis lines.
- Increasing access to shelter in rural communities through shelter operational support.
- Addressing homelessness by supporting street outreach.



If Awarded: Reporting Requirements

Awardees will be required to submit narrative and financial reports 30 days following the end of the funding period, reporting on activities and outcomes included in the proposal.

Report forms may vary and potentially include videos or photos, utilizing other materials or verbal reporting.

How to be a Competitive Applicant



Selection Criteria

The most competitive applications will:

- Respond to gaps in the California State budget
- Promote health and address health disparities
- Support projects that improve health and quality of life
- Demonstrate approaches to solving issues that impact health, such as education, employment, housing, environment, neighborhood safety and other drivers of health outcomes



Selection Criteria (continued)

The most competitive applications will:

- Clearly explain why the applicant organization and, where appropriate, partner agencies are best suited to be successful with the proposed project
- Make the case for need related to the population to be impacted



Selection Criteria (continued)

The most competitive applications will:

- Leverage resources and/or demonstrate sustainability, if applicable
- Describe the anticipated difference the project would make
- Include a reasonable project scope and budget



Other Considerations in Final Selection

- Geographic diversity
- Demographic diversity
- Range of project areas



Proposal Writing Tips

- Read and follow application guidelines and instructions.
- Verify your organization is eligible.
- Answer questions clearly and concisely.
- Clearly explain your proposed project, including what exists today and what change will result with funding from Sierra Health Foundation.



Proposal Writing Tips (continued)

- Check for consistency in the project description, and budget line items.
- Have someone who is not involved in the project read your draft application and tell you what they think you're applying for.
- Review the Attachments Checklist to ensure you have all required documents.
